Keeping All of God's Commandments

The Church of Jesus Christ of Latter-day Saints teaches that Godhood is in fact Fatherhood. The Gods come in pairs -- Mother and Father. The fullness of the priesthood is Godhood or Fatherhood, with God the Father and Heavenly Mother being the prime example where our spirit bodies and physical bodies are concerned. Jesus achieved Godhood, which means that He achieved Fatherhood -- both spiritually and physically. Isaiah 53: 10 tells us that Jesus Christ shall see his seed. This means that he will have seed, both spiritually and physically.

The first great commandment is to marry and have children. To fulfill all righteousness, Jesus Christ kept ALL of God's Commandments. (Genesis 1: 28.)

We know that Jesus Christ had to be married, or the Jews would not have permitted him to be a rabbi and a teacher. That was the law. Jesus Christ definitely had to be married in order to be a rabbi and a teacher. The real question is whether Jesus had children or not.

According to legend, Jesus had three or four children of his own; and, Jesus had also adopted John the Beloved. Remember, legends are often true, or have an element of truth within them.

We know that Jesus Christ had to have children of his own, or the Jews would have considered him to be cursed by God. Back in those days, being without children was taken as a sign from God that you have been cursed by God. God the Father wouldn't have permitted his Son to seem cursed. Jesus would have participated in all of the ordinances and rites necessary for salvation and exaltation -- including marriage and fatherhood.

Jesus himself was now more than thirty years of age and would have probably been married, as was customary for Jewish men to do in their late teens: "At five years old one is ready for the scripture, at ten years for the Mishnah, at thirteen for the commandments, at fifteen for the

Talmud, at eighteen for marriage, at twenty for the pursuit of righteousness, at thirty for full strength."

Had Jesus not been married, we would undoubtedly read of accusation after accusation against him because marriage was number one of the commandments God had given from the beginning to the meridian of time. As we have no record of objections to his teaching, it would appear that he had already complied with this most important commandment. (Just an observation of Jewish culture.)

Joseph Smith taught that the Savior obeyed all ordinances necessary for exaltation: "If a man gets a fullness of the priesthood of God, he has to get it in the same way that Jesus Christ obtained it, and that was by keeping all the commandments and obeying all the ordinances of the House of the Lord."

If Jesus hadn't been married, the Jews and the Pharisees wouldn't have let him teach; and, we would have heard about it.
